

## **SUNBUTTER GFAF EXPO PHOTO BOOTH SWEEPSTAKES OFFICIAL RULES.**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

**1. Eligibility:** The “SunButter GFAF Expo Photo Booth Sweepstakes” (the “Sweepstakes”) is open only to those who are 18 or older as of the date of entry. The Sweepstakes is only open to legal residents of The United States and is void where prohibited by law. Employees of SunButter (“Sponsor”), The Zimmerman Group (“Administrator”), event host, and their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members (defined as parents, spouses, children, siblings, grandparents, and their respective spouses) and/or those living in the same household of each are not eligible to win. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Void where prohibited. **LIMIT:** One (1) entry per entrant in this Sweepstakes. All entries must be received by Sponsor during the Entry Period. Any attempt by any participant to obtain additional entries beyond the limit by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant’s entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, void, unintelligible, or misdirected entries, which will be disqualified. The “authorized account holder” is

the natural person assigned to an email address by an Internet access provider, online service provider, Internet service provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being the authorized entrant/account holder. If a dispute cannot be resolved to Sponsor's satisfaction, the winning entrant maybe deemed ineligible. The winner will be notified via social media private message within two weeks of the final event day. The winners will be selected in a random drawing under the supervision of the Sponsor. SunButter shall have no liability for a winner's failure to receive notices due to winner's spam, junk e-mail or other security settings or for winner's provision of incorrect or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within 7 days from the time award notification was sent, or fails to timely return a completed and executed declaration and releases as required, prize may be forfeited and an alternate winner selected.

The receipt by winner of the prize offered in this Sweepstakes is conditioned upon compliance with any and all federal and state laws and regulations. Rights Granted by you:** By entering this content you understand that SunButter, anyone acting on behalf of SunButter, or its respective licensees, successors and assigns will have the right, where permitted by law, without any further notice, review or consent to print, publish, broadcast, distribute, and use, worldwide in any media now known or hereafter in perpetuity and throughout the World, your entry, including, without limitation, the entry and winner's name, portrait, picture, voice, likeness, image or statements about the Sweepstakes, and biographical information as news, publicity or information and for trade, advertising, public relations and promotional purposes without any further compensation.

**9. Terms:** SunButter reserves the right, in its sole discretion to cancel, terminate, modify or suspend the Sweepstakes should (in its sole discretion) a virus, bugs, non-authorized human intervention, fraud or other causes beyond its control corrupt or affect the administration, security, fairness or proper conduct of the Sweepstakes.
