## SUNBUTTER BACK-TO-SCHOOL SANDWICH CONTEST OFFICIAL RULES.

## NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING. VOID WHERE PROHIBITED. VALID IN THE UNITED STATES AND CANADA ONLY. ENTRY IN THIS CONTEST CONSTITUTES YOUR ACCEPTANCE OF THESE OFFICIAL RULES.

**1. BINDING AGREEMENT:** In order to enter the SunButter Back-to-School Sandwich Contest (the "Contest"), "Entrant(s)" or "You" must agree to the Official Rules. Therefore, please read these Official Rules ("Rules") prior to entry to ensure you understand and agree. You agree that submission of an entry in the Contest constitutes agreement to these Rules. You may not submit an entry to the Contest and are not eligible to receive the prizes described in these Rules unless you agree to these Rules. These Rules form a binding legal agreement between you and SunButter with respect to the Contest.

2. ELIGIBILITY: To be eligible to enter the Contest, an Entrant must: (a) be a legal resident of The United States or Canada; (b) be 18 years of age, or older. Contest is void where prohibited by law. Employees of SunButter ("Sponsor"), The Zimmerman Group ("Administrator"), Pancake Laboratories, Inc. The Contest is in no way sponsored, endorsed or administered by, or associated with Facebook.

**4. CONTEST PERIOD:** The Contest begins on or about August 1, 2015, and ends September 1, 2015 ("Contest Period"). All dates are subject to change. All online entries must be received by August 31, 2015, 11:59 PM CST. Administrator's computer is the official time keeping device for the Contest.

**5. HOW TO ENTER:** The Contest must be entered by submitting an entry using the online form provided on the SunButter Facebook Page. To enter, locate the Sandwich Contest tab found on the SunButter Facebook Page at http://www.facebook.com/SunButter, click on the Sandwich Contest tab and then

accept the Contest application (the "Application"). Once you have accepted the Application, completely fill out the entry form and submit it in accordance with the on-screen instructions. You must complete all required information to be eligible to enter to win the prize. LIMIT: One (1) entry per person in this Contest. All entries must be received by Sponsor during the Entry Period. You must also be a registered member of the Facebook website located at www.facebook.com and in compliance with the Facebook Terms located at http://www.facebook.com/ terms.php. Membership on Facebook is free, and can be obtained by visiting www.facebook.com and following the on screen instructions to register for and open an account. An entrant must be the rightful owner (or have authorized use) of the e-mail address identified with the participant's Facebook account. Multiple participants are not permitted to share the same email address or Facebook account. Any attempt by any participant to obtain additional entries beyond the limit by using multiple/different email addresses, Facebook accounts, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disgualified. Use of any automated system to participate is prohibited and will result in disgualification. Sponsor is not responsible for lost, late, incomplete, invalid, void, unintelligible, or misdirected entries, which will be disgualified. In the event of a dispute as to an entrant's entry, the natural person who is the authorized account holder of the email address identified with the participant's Facebook account will be deemed to be the entrant, but only if that person is otherwise eligible to enter the Contest. The "authorized account holder" is the natural person assigned to an email address by an Internet access provider, online service provider, Internet service provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being the authorized account holder. If a dispute cannot be resolved to Sponsor's satisfaction, the winning entrant maybe deemed ineligible. **6. SANDWICH REQUIREMENTS**. The Sandwich Recipe ("Recipe") must meet the following criteria ("Sandwich Requirements"):

- Sandwich Recipe must include any SunButter variety as the primary ingredient.
- Sandwich Recipe must be in English and must specify which variety of SunButter is used (Creamy, Natural, Crunch, No-Stir, Organic, No Sugar Added).
- Sandwich Recipe must clearly state each ingredient in exact common U.S. household measurements and include step-by-step preparation instructions. Sandwich Recipe must also include cooking times if necessary.

- Sandwich Recipe ingredients must be widely available and found in most grocery stores.
- Sandwich Recipe must not have been previously published, must not be awaiting publication, nor may be submitted for publication consideration during the Contest Period.
- Sandwich Recipe entry must be an original work created by the person entering the Contest.
- Entrant must include Sandwich Recipe title. The Sandwich Recipe title may not include any person's or brand name, except for SunButter brand.
- Sandwich Recipe must not include any content that is derogatory, offensive, threatening, defamatory, disparaging, libelous or contain any content that is inappropriate, indecent, sexual, profane, torturous, slanderous, discriminatory in any way, or that promotes hatred or harm against any group or person, or otherwise does not comply with the theme and spirit of the Contest.
- Sandwich Recipe must not contain content, material or any element that is unlawful, or otherwise in violation of or contrary to all applicable federal, state, or local laws and regulation including the laws or regulations in any state where the sandwich are created.
- Sandwich Recipe must not contain any content, material or element that displays any third party advertising, slogan, logo, trademark or otherwise indicates a sponsorship or endorsement by a third party, commercial entity or that is not within the spirit of the Contest, as determined by Sponsor, in its sole discretion.
- Sandwich Recipe must be original, unpublished works that does not contain, incorporate or otherwise use any content, material or element that is owned by a third party or entity.
- Sandwich Recipe cannot contain any content, element, or material that violates a third party's publicity, privacy or intellectual property rights.
- Sandwich Recipe is not the subject of any actual or threatened litigation or claim.
- Entrant may not include any disparaging remarks relating to the Sponsor or a third party.

During the Contest Period, the Sponsor, its agents and/or the Judges (defined below) will evaluate the Sandwich Recipes to ensure that they meet the Sandwich Requirements. The Sponsor reserves the right, in its sole discretion, to disqualify any Entrant who submits a Sandwich Recipe that does not meet the Sandwich Requirements. Incomplete entries or entries not complying with these Rules are subject to disqualification.

**7. JUDGING:** Initial Judging will be done by a qualified panel of judges and will consider the following criteria: (i) Creativity/Originality, (ii) Ease of use for school lunches or snacks, and (iii) Likely Taste. Final Judging: The top 3 Sandwich Recipes will be prepared and judged by a qualified panel of judges who will assign points based on the following criteria and point system: Creativity/

Originality (1-10 points), Ease of use for school lunches or snacks (1 -10 points), and Taste (1-10 points). The highest scoring Sandwich Recipe entrant will be declared the Winner. In the event of a tie, the winning Sandwich Recipe that has the highest score for Taste will be declared the Winner. In the case of duplicate Sandwich Recipes, the first entry received will be judged. Decisions of the judges are final and binding.

**8. WINNER SELECTION AND NOTIFICATION:** On or about September 1, 2015, winner of the Contest will be selected. Winner will be notified via email to the email address they entered the Contest with within five (5) days following the winner selection. SunButter shall have no liability for a winner's failure to receive notices due to winner's spam, junk email or other security settings or for winner's provision of incorrect or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within 7 days from the time award notification was sent, or fails to timely return a completed and executed declaration and releases as required, prize may be forfeited and an alternate winner selected.

The receipt by winner of the prize offered in this Contest is conditioned upon compliance with any and all federal and state laws and regulations. RIGHTS GRANTED BY YOU:** By entering this Contest you understand that SunButter, anyone acting on behalf of SunButter, or its respective licensees, successors and assigns will have the right, where permitted by law, without any further notice, review or consent to print, publish, broadcast, distribute, and use, worldwide in any media now known or hereafter in perpetuity and throughout the World, your Sandwich Recipe (including, without limitation, the entry and winner's name, portrait, picture, voice, likeness, image or statements about the Contest, and biographical information) as news, publicity or information and for trade, advertising, public relations, SunButter recipe books and promotional purposes without any further compensation.

**10. PRIZES:** Winner will receive \$500 intended for their child's education, or for a school's foodservice department. Actual/appraised value may differ at time of prize award. The specifics of the prize shall be solely determined by the Sponsor. No cash or other prize substitution permitted except at Sponsor's discretion. The prize is nontransferable. Any and all prize related expenses, including without limitation any and all federal, state, and/or local taxes shall be the sole responsibility of the winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by winner is permitted. Acceptance of prize constitutes permission for SunButter to use winner's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law. In the event there are not enough

eligible entries, not all prizes will be awarded. If a potential winner is unable for whatever reason to accept his or her prize, then SunButter reserves the right to award the prize to another entrant.

INTERNET AND DISCLAIMER.** SunButter is not responsible for any malfunction of the entire Contest Site or any late, lost, damaged, misdirected, incomplete, illegible, undeliverable, or destroyed Sandwich recipes and photos or votes due to system errors, failed, incomplete or garbled computer or other telecommunication transmission malfunctions, hardware or software failures of any kind, lost or unavailable network connections, typographical or system/ human errors and failures, technical malfunction(s) of any telephone network or lines, cable connections, satellite transmissions, servers or providers, or computer equipment, traffic congestion on the Internet or at the Contest Site, or any combination thereof, including other telecommunication, cable, digital or satellite malfunctions which may limit Entrant's/consumer's ability to participate/ vote respectively. SunButter is not responsible for the policies, actions, or inactions of others, which might prevent Entrant from entering, participating, and/ or claiming a prize in this Contest. Sponsor's failure to enforce any term of these Rules will not constitute a waiver of that or any other provision. Sponsor reserves the right to disqualify Entrants who violate the rules or interfere with this Contest in any manner. 15. RIGHT TO CANCEL, MODIFY OR DISQUALIFY. If for any reason the

Contest is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes which corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Contest, SunButter reserves the right at its sole discretion to cancel, terminate, modify or suspend the Contest. SunButter further reserves the right to disqualify any Entrant who tampers with the submission process or any other part of the Contest or Contest Site. Any attempt by an Entrant to deliberately damage any web site, including the Contest Site, or undermine the legitimate operation of the Contest is a violation of criminal and civil laws and should such an attempt be made, SunButter reserves the right to seek damages from any such Entrant to the fullest extent of the applicable law.

**16.
